ORDER:

In the reference 1st read above, Rules have been issued for Selection of Teaching Staff in Private Elementary Teacher Training Institutions as per NCTE Norms, 2007.

2. In the reference 2nd read above, Revised Rules for Selection of Teaching Staff in Private Elementary Teacher Education Institutions agreeing for certain changes in the existing Rules were issued in view of the new Regulations called National Council for Teacher Education (Recognition Norms & Procedure) Regulations, 2009 by NCTE.

3. In the reference 3rd read above, the NCTE, New Delhi has issued new Regulations called National Council for Teacher Education (Recognition Norms & Procedure) Regulations, 2014 superseding the NCTE Norms, 2009 vide Notification dated 28th November, 2014, relating to the Teacher Education Programmes in the country.

4. In the reference 4th read above, the Director of School Education, Telangana, Hyderabad has submitted proposals to the Government based on the new Regulations notified by NCTE vide Notification dated 28.11.2014 called National Council for Teacher Education (Recognition Norms & Procedure) Regulations, 2014 and requested to issue Orders in the matter superseding the earlier orders (references 1 and 2).

5. Government after careful examination of the proposal of the Commissioner & Director of School Education, Telangana, Hyderabad, in supersession of the references 1st and 2nd read above, hereby order the following regarding selection and approval of Teaching and Non-Teaching Staff in Private Elementary Teacher Training Institutions in the State.

1. **The details of Academic and Administrative Staff shall be as under:**

1.1 Academic Faculty

The Designation, Number and Subject Specialization for the Posts shall be as given in the Table below. The Principal or HOD as the case may be is included in the faculty.

1.2.2 Language / Medium Study Qualifications:

- A. The faculty appointed shall be eligible to teach in the Medium in which D.El.Ed. is conducted by the institution concerned.
- B. Further, the Unit size of D.El.Ed Programme as per NCTE Regulations, 2014 is 50 students. The Medium to be opted shall be only one for the entire one Unit intake. Split up of the Unit is not allowed to offer one Unit in multiple media. In case of institutions having more than one Unit intake, Second and Third Medium can also be opted depending on the number of Units of Intake sanctioned by SRC, NCTE. Therefore, all the Eight persons to be appointed for 'One' Unit of any particular medium shall be eligible to teach in that medium only.
- C. Criteria for deciding eligibility to teach in any particular medium - The candidates who **have (i) passed either SSC (or its equivalent) Examination or Intermediate (or its equivalent) or Degree Examination in the concerned medium of instruction or (ii) have studied the concerned Language as First Language in SSC (or its equivalent) or as Part I in Intermediate (or its equivalent) or as Second Language in Intermediate (or its equivalent) or as a Subject in Degree are eligible** to teach in that particular medium

1.4 Terms and Conditions of Service:

- a. Type of Appointment: Full time
- b. Age of Superannuation: shall be as per the policy of the State Government in respect of both Academic and Administrative Staff.
- c. Pay Scales: shall be as may be prescribed by the State Government.
- d. Disbursement of Pay: Through Account Payee Cheque
- e. Other Benefits: The Management of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund, etc.

2. Selection Procedure for Appointment of Teaching Faculty:

- a. The Management of the Institution shall issue a Notification in Two leading News Papers i.e. One in Telugu / Urdu and One in English, notifying the number of vacancies with post details giving a time of Two weeks for submission of applications
- b. The Management shall constitute a Staff Selection Committee with the following members:
 1. Secretary / Correspondent of the Society
 2. President of the Society or her / his Nominee
 3. The Principal of the DIET concerned (as given in Rule 2(m) of G.O.Ms. No. 10 School Education (Prog.II) Department Dated: 12-04-2017)
 4. One subject expert nominated by the Director, SCERT, Telangana, Hyderabad.
- c. Selection of Candidates shall include both Written Test and Interview
- d. The Management shall take the video graph of the Proceedings of the Selection
- e. The list of selected candidates shall be submitted to the Director, SCERT, Telangana for approval in the Proforma annexed as Annexure III along with the following documents:
 - i. Letter of Intent issued by the NCTE in case of new Institutions and Formal Recognition Order in case of existing institutions,

- ii. Staff Approval Fee as prescribed in these Rules
- iii. Minutes of the Selection Committee,
- iv. List of Candidates who have attended the Selection process with marks awarded,
- v. Soft Copy of the Video graph of the proceedings of the Selection,
- vi. Original Certificates of the selected candidates,
- vii. Individual Affidavits from the selected candidates in the Proforma annexed as Annexure I,
- viii. Affidavit from the Correspondent / Secretary of the Institution in the Proforma annexed as Annexure II,
- ix. Details of the website of the institution showing all the details as mentioned at Regulation 7 (14) of the National Council for Teacher Education (Recognition Norms & Procedure) Regulations, 2014.

- f. The Director, SCERT shall constitute a Committee at SCERT with the faculty members of SCERT/DIETs/ CTEs/IASE for scrutiny of the proposals submitted by the Managements for approval of the Staff Lists and the Director, SCERT shall approve the staff in the Proforma Annexed to these Rules as Annexure IV.

3. Travelling allowance, Dearness allowance, Sitting Charges to the Members of the Staff Selection Committee shall be borne by the Managements of the Institutions.

4. a. Fee for Approval of Staff Lists by Director, SCERT: Rs.10,000/- (Ten Thousand Only) in the form of Demand Draft drawn in favour of the Director SCERT, Telangana, payable at Hyderabad.

b. The Fee remitted by the Private Elementary Teacher Education Colleges for the Staff Approval to the Director, SCERT shall be utilized for meeting the expenditure relating to the functions of the conduct of Teacher Education Programmes.

6. The Commissioner and Director of School Education and the Director, State Council for Educational Research and Training are requested to take necessary action accordingly.
