## ORDER:

In the references 1<sup>st</sup> read above, the Commissioner & Director of School Education, Telangana, Hyderabad, has requested to allow DIET, Medak to start Diploma in Pre School Education Programme (DPSE) Two years course with an annual intake of 50 students (1 unit) from the Academic Year, 2018-2019.

- 2. In the reference 2<sup>nd</sup> read above, the National Council for Teacher Education (NCTE), South Regional Committee, Bangalore granted recognition to DIET, Medak for conducting Diploma in Pre School Education Programme (DPSE) Course of two years duration, with an annual intake of 50 students (1 Unit) from the Academic Year, 2017-2018.
- 3. After careful examination of the matter and in pursuance of the orders issued by the National Council for Teacher Education, South Regional Committee, Bangalore, Government hereby permit the Commissioner & Director of School Education, Hyderabad, to start Diploma in Pre School Education Programme (DPSE) Two Years programme in DIET, Medak, with an Annual Intake of 50 students in English Medium from the Academic Year, 2018-2019.
- 4. In this regard the Commissioner & Director of School Education (C&DSE), Hyderabad / Director SCERT is informed that they shall take necessary action as per the NCTE norms and existing rules and regulations regarding the working days, attendance of students, teachers, conducting of DPSE Annual Examinations, etc., for this programme.
- 5. Regarding the admissions necessary amendments are being issued in the DEECET Rules issued vide G.O.Ms.10, School Education (Prog.II) Dept., dated 12.04.2017.
- 6. Regarding the Fees, C&DSE must follow G.O.Ms.No.128, Edn. (SE-Trg.III) Dept., dt.20.10.2003 on par with the D.El.Ed. programme being conducted in the Govt. DIETs.
- 7. The DPSE curriculum prepared by the SCERT shall be implemented for the conduct of this programme.
- 8. The DPSE internship programme shall be implemented in the Govt. Primary Schools where the anganwadi centres are functioning in the Govt. Primary Schools.
- 9. The Director, Govt. Examinations, TS, Hyderabad shall conduct the final theory and practical examinations for both first and second year of this DPSE programme.

- 10. The faculty working in DIET, Medak can be shared to conduct this programme under the NCTE norms of the composite institution. The C&DSE/Director, SCERT, Hyderabad may engage 7 Guest Faculty as per the Guidelines available for the other DIETs in this regard, with an Honorarium of Rs.18000/- per month for full time guest faculty and Rs.12000/- per month for professional support staff, by meeting the expenditure from the budgetary provisions provided to the Director, SCERT. The existing infrastructure of DIET, Medak shall be utilised for running this DPSE programme at present.
- 11. The Commissioner & Director of School Education, Telangana, Hyderabad and the Director, SCERT, Hyderabad, shall take necessary further action accordingly.
