In the G.O. 4<sup>th</sup> read above, the Government have issued orders permitting the Commissioner & Director of School Education, Hyderabad to start Diploma in Pre School Education (D.P.S.E) 2 years programme in District Institute of Education and Training (DIET), Medak with an annual intake of 50 students in English Medium from the Academic Year, 2018-2019.

The Commissioner & Director of School Education, Hyderabad, in his letter 5<sup>th</sup> read above, has stated that as on today National Council of Teacher Education (NCTE) in the letter 3<sup>rd</sup> read above has granted permission to start Diploma in Pre School Education (DPSE) in one Private Management i.e. at St. Peters Educational Association, Hanmakonda village, Vidyanagar, Hanmakonda Taluk & City, Warangal District-506001 with annual intake of 50 students. Hence, there is a need for the issue of rules for grant of affiliation for the private institutions and fee structure for the DPSE programme and thus he has proposed an amendment to the G.O.Ms.No.18, SE (PE-Prog.II) Dept., dt.14.05.2014.
