**ORDER:-**

The 'Right of Children to Free and Compulsory Education Rules, 2010' were issued in G.O.Ms.No.20, School Education (PE-Prog.1) Department, dt:03.03.2011 and further amendments to such Rules issued in G.O.Ms.No.130, S.E(PE.Prog-1)Deptt, dt:09.09.2011 and G.O.Ms.No.41, S.E(PE-SSA) Deptt, dt:19.06.2013 vide G.Os 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> read above and **the same rules were adapted by the Government of Telangana as per para (6) of the G.O 4<sup>th</sup> read above.**

2) The Government of India, Ministry of Human Resource Development Department of School Education and Literacy in their letters 5<sup>th</sup> to 7<sup>th</sup> read above, has informed that the Learning Outcomes have been incorporated in the Central Rules to the Right of Children to Free and Compulsory Education Act, 2009 (Central Act 35 of 2009) by amending Rule 23(2) of the Rules and requested to incorporate these Learning Outcomes in the State Right of Children to Free and Compulsory Education Rules, 2010.
